

The award

The CSP Small Contractor / Sub Contractor Innovation Award will be awarded to a small contractor who has introduced an innovation / change to the way that they operate that has made improvements to health and safety within the last three years. This may have been a small engineering change or indeed a management change that has been adopted by the company to address a safety problem that existed. The aim of this award is to highlight and reward the commitment of small enterprises to improving health and safety performance within their organisations.

How to apply for the award?

Candidates may nominate themselves or indeed they may be nominated by a client, main contractor or worker – anyone who is of the opinion that their organisation has grasped a health and safety issue and introduced a novel / innovative idea to address a problem. The action taken should have been instigated in the last three years and should have been introduced specifically to resolve a health and safety issue.

Who is eligible?

Any small contractor / sub contractor (employing less than 20 people) who work in the construction industry.
