#### **HSA Stress Reduction Programme**

Experts at the Health and Safety Authority are helping organisations implement the new Workplace Management Standards for stress. These standards were developed in order to allow personnel within organisations carry out internal audits, identify issues easily, interpret data and develop realistic and practical interventions so that systems of work can be reasonably regarded as safe.

The HSA has been approached by the North West Advisory committee to assist organisations in the West and North West region who to-date have no systematic method of dealing with stress-related issues. Stress-related issues can lead to major difficulties for organisations as well as those suffering from stress themselves including high absenteeism, high staff turnover, IR disputes and performance deficits.

#### Patricia Murray HSA Occupational Psychologist/Inspector

**Patricia Murray** is an Organisational Psychologist at the Health and Safety Authority, where she develops programmes for handling workplace stress and bullying. She was a member of the Government's 2005 Expert Advisory Group on Bullying at Work and was one of the authors of the Code of Practice on the Prevention and Management of Bullying at Work (2007). She contributes expert opinion to television and radio in Ireland.

Patricia holds an honours degree in psychology, a Master of Science in Organisational Psychology and M Phil in Psychoanalytic Studies from Trinity College Dublin and a Post-graduate Diploma in Health and Safety at Work.
