

European Communities (Carriage of Dangerous Goods by Road and Use of Transportable Pressure Equipment) Regulations 2011 to 2021

Competent Authority Exemption 02/2023

Applicable To National Road Transport Only

Carriage of UN 2546 TITANIUM POWDER DRY, 4.2, PGI, as waste

The Health and Safety Authority, as Competent Authority appointed under Regulation 10 of the European Communities (Carriage of Dangerous Goods by Road and Use of Transportable Pressure Equipment) Regulations 2011 to 2021, and in accordance with Regulation 5(4)(a), hereby exempts Veolia Environmental Services Ltd from ADR 6.1.3 with respect to the packaging code used for the carriage by road of UN2546 TITANIUM POWDER DRY, Class 4.2, PG I.

Purpose

This national exemption permits Veolia Environmental Services Ltd to transport by road waste classified as UN2546 TITANIUM POWDER DRY, Class 4.2, PG I in packaging displaying the code 1A1W/Y100/S/19/B/1565.208-160018. The same packaging has been re-tested and re-certified to bear the code 1A1W/X100/S/*B/1565.2068-160018 (X100 = Y150), 1A1W/Y1.6/160/* B/1565.2068-160018. The transport operation is from Depuy Synthes (Building 2), Ringaskiddy, Cork, to the Ports of Dublin and Cork

The transport operation shall comply with the provisions contained in this document.

- 1. The package contents shall be blanketed with argon gas and shall be closed according to the manufacturer's instructions.
- 2. The packages shall be loaded and secured in accordance with the provisions of the IMO/ILO/UNECE Code of Practice for Packing of Cargo Transport Units.
- 3. A copy of this exemption and a copy of the certificate of approval No. 220221, issued by IBE-BVI (Belgian Packaging Institute) on 15 November 2022, shall be attached to the transport document, and shall be made available to anyone who has a legitimate interest in the transport operation.
- 4. In all other respects, the transport operations performed in accordance with this exemption will comply with the relevant requirements of ADR.

5. Any incident resulting in loss of containment of a substance during the transport journey shall be reported immediately by the participant in control of the transport operation to:

6. The Authority may withdraw this exemption for failure to observe any of these conditions or for any other reason, which the Authority deems sufficient.

This exemption is effective immediately and expires on 30 April 2024.
