

European Communities (Carriage of Dangerous Goods by Road and Use of Transportable Pressure Equipment) Regulations 2011 to 2023

Competent Authority Exemption 07/2023

Applicable To National Road Transport Only

Carriage of UN1965, HYDROCARBON GAS MIXTURE, LIQUEFIED, N.O.S. (Propane) in tanks constructed to EN12493 inclusive of Annex C

The Health and Safety Authority, as Competent Authority appointed under Regulation 10 of the European Communities (Carriage of Dangerous Goods by Road and Use of Transportable Pressure Equipment) Regulations 2011 to 2023, and in accordance with Regulation 5(4)(a), hereby exempts Calor Teoranta from Regulation 10(10)(c).

Purpose

The provisions of this exemption apply to four tanks manufactured by OMSP Macola Industrial S.r.I, 35020 Saonara, Italy, to EN12493 inclusive of Annex C, and issued with certificates of type approval and initial inspection by ITALCERT SRL, not specifically accredited for this activity.

Serial Number: 2951 (2014 semi-trailer)
Serial Number: 3360 (2018 semi-trailer)
Serial Number: 3590 (2020 semi-trailer)

Serial Number (tank): 3692 (2021 rigid tanker)

This exemption permits the continued use of the tanks listed until the date of their next periodic or intermediate inspection (whichever is the earliest) by an inspection body accredited to perform inspection activities related to tanks manufactured to EN12493 inclusive of Annex C.

This exemption has been issued on the basis of receipt of a report of design approval for each tank, to indicate that a satisfactory review of the tank design in accordance with EN12493 inclusive of Annex C, has been conducted by a Type A inspection body accredited to perform type approval, initial inspection, periodic and intermediate inspection and exceptional inspection of tanks manufactured to EN12493 inclusive of Annex C. A certificate of exceptional inspection will be issued for each tank at the time of the next periodic or intermediate inspection.

The transport operation shall comply with the provisions contained in this document.

- 1. This exemption applies only to tanks with the serial numbers listed above.
- 2. The four tanks may remain in service from the date of issue of this exemption until the date of the next periodic or intermediate inspection, whichever is the earliest as appropriate, by an inspection body accredited to perform such activities for tanks manufactured to EN12493 inclusive of Annex C.
- 3. In all other respects, the transport operations performed in accordance with this exemption will comply with the relevant requirements of ADR.
- 4. A copy of this exemption shall accompany the transport documentation, and shall be made available to anyone who has a legitimate interest in the transport operation.
- 5. Any incident resulting in loss of containment of a substance during the transport journey shall be reported immediately by the participant in control of the transport operation to the emergency services and:

6. The Authority may withdraw this exemption for failure to observe any of these conditions or for any other reason, which the Authority deems sufficient.

This exemption is effective immediately and expires on 01 September 2026.
