A key focus will be those companies with little or no experience of the registration process and practical advice on how to prepare and submit a registration dossier will be provided.

About the speakers:

Majella Cosgrave joined the HSA in 1999. She currently works as a senior policy inspector with responsibility for stakeholder communication, CLP policy and REACH work areas such as identification of substances of very high concerns (SVHCs), evaluation and prioritisation of substances for authorisation. She is Ireland's nominee to ECHA's Member State Committee.

Laura Walin joined ECHA, the European Chemicals Agency, in May 2008. She has worked in various activities at ECHA, including the ECHA Helpdesk, setting up the practical solutions for 2010 registrants for the Directors' Contact Group, CSA Development Programme and the CSR/ES Roadmap drafting and its implementation. She is currently responsible for co-ordinating ECHA's activities for the 2018 registration deadline under ECHA's REACH 2018 Roadmap.

István Mak joined ECHA in 2010. He is working in the Dossier Submission & PIC Unit and is responsible for joint submission related issues within the unit. During 2010 and 2013, István was responsible for co-ordinating all company support activities in the context of the REACH registration deadlines, including proactive telephone and email support from ECHA to companies experiencing technical issues with the Registration process.

Karen Collins joined the HSA in 2008, where she works as a human health toxicologist contributing to the manual screening and evaluation of registered substances. Karen also works on the chemicals helpdesk and is Ireland's nominee to ECHA's REACH HelpNet group of Member State Helpdesks.
