





### **Construction Skills Certifications in ROI/UK/NI**

This paper attempts to summarise arrangements for plant construction skills training in the Republic of Ireland, in Northern Ireland and the remainder of the United Kingdom (i.e. CSCS, CSR and CPCS). Further details are provided in the Appendix overleaf.

### 1) Are all skilled operator cards accepted in the Republic of Ireland?

- No, not all cards are the same.
- It is a legal requirement to possess a SOLAS card when undertaking any construction activity specified in Schedule 5 of the Safety, Health and Welfare at Work (Construction) Regulations 2013.
- All Persons who are carrying out any activity listed in in Schedule 5 of the Safety, Health and Welfare at Work (Construction) Regulations 2013 MUST HAVE a SOLAS CSCS Card, No other Cards are acceptable.

### 2) What UK qualifications are 'automatically accepted' in the Republic of Ireland?

- No UK Construction Skill Cards are acceptable.
- Only a SOLAS CSCS experienced operator cards are accepted on construction sites in the Republic of Ireland (i.e. CPCS or CSR plant cards are NOT accepted).

### 3) Can I transfer a UK Competent Operator Card to a SOLAS CSCS Operator Card?

Yes, subject to review/assessment by SOLAS, the competent authority. All applications will be considered on an individual basis. Email the following to SOLAS: <u>RPQ@solas.ie</u>

- a) A detailed CV,
- b) Reference(s) from previous employers to confirming hours worked, and
- c) A scan of the UK competent operator's card, and associated certification.

### 4) Can I transfer an ROI CSCS Plant Operator Card to a UK CPCS Competent Operator Card?

Yes, you can apply to the National Construction Training Centre in Mount Lucas for the equivalent CPCS Plant Operators Card. All applications will be considered on an individual basis. To qualify, you must undertake a CPCS theory test, a Skills and Experience Interview and the Construction Skills Health, Safety and Environment test. ### Appendix

### **1.0** Republic of Ireland – CSCS Arrangements

The Construction Skills Certification Scheme (CSCS) provides for the training, assessment, certification and registration of non-craft operatives within the construction sector. Information on CSCS is provided under Schedule 5 of the Safety, Health & Welfare at Work (Construction) Regulations 2013. The list of tasks includes:

(a) Scaffolding - basic;

(b) Scaffolding - advanced;

(c) Mobile Tower Scaffold

(d) Tower crane operation;

(e) Self erecting tower crane operation - where employee has not been trained on tower crane

(f) Slinging/signalling;

(g) Telescopic handler operation;

(h) Tractor/dozer operation;

(i) Mobile crane operation;

(j) Crawler crane operation;

(k) Articulated dumper operation;

(I) Site dumper operation;

(m) 180° excavator operation;

(n) Mini-digger operation - where employee has not been trained for a 360° excavator digger

(o) 360° excavator operation;

(p) Roof and wall cladding/sheeting;

(q) Built-up roof felting;

(r) Signing, Lighting and Guarding on roads

(s) Locating under-ground services

(t) Shotfiring

(u) assisting in the implementation of health and safety at roadworks.

### 2.1 Construction Plant Competence Scheme (CPCS)

The Construction Plant Competence Scheme (CPCS) is owned by NOCN Group and provides skills cards for the plant sector of the Construction and allied industries. For full details, visit: <u>https://www.nocnjobcards.org/CPCS/</u>

The plant operator process is supported by CPCS testers that are certified as trained and competent by CPCS. NOCN Group is a not-for-profit organisation dedicated to creating opportunities through learning and skills. Membership of the scheme is voluntary but is mandatory on many construction sites and in other work environments. The requirements to renew a CPCS Competent Operator card includes the need to undertake the CPCS renewal test, for which a specific set of questions for each module (category) will be attempted.

### 2.2 UK Construction Skills Certification Scheme (CSCS)

CSCS cards provide proof that individuals working on construction sites have the required training and qualifications for the type of work they carry out. <u>Holding a CSCS card is not a legislative requirement</u>, in the UK.It is entirely up to the principal contractor or client whether workers are required to hold a card before they are allowed on site. However, most principal contractors and major house builders require construction workers on their sites to hold a valid CSCS card.

CSCS is a not-for-profit limited company. Its directors are from employer organisations and unions representing the breadth of the industry. The Scheme's application processing and contact centre is delivered under contract by CITB.

### 2.3 Construction Industry Scaffolders Record Scheme (CISRS)

The Construction Industry Scaffolders Record Scheme (CISRS) has been the industry recognised scaffold training scheme for over 40 years. It is the preferred scaffolding qualification of all the major organisations including CSCS, NSAC, HSE, Build UK, UNITE, UCATT and the largest scaffold systems manufacturers. ### 3.0 Northern Ireland - CSR

The Construction Skills Register (CSR) is a register of construction workers who have completed the industry approved CSR health and safety training course and assessment in Northern Ireland. There are five categories of CSR, as follows:

- 1. General, Skilled and Craft Cards
- 2. Plant Operator Cards
- 3. Supervisor and Manager Cards
- 4. Professional Cards
- 5. Health and Safety Trained Card.

CSR Plant Operator Cards cover a wide range of construction plant and equipment, including:

### • Red Card - Trained Operator

All candidates are required to complete the CSR 1 Day Health & Safety Training. All candidates are also required to complete the Construction Awards Alliance (CAA) Plant Award/Certificate. A profiling exercise is completed by the Training Provider to determine prior experience and ability



and to assess whether the candidate requires training. If training is required, the CSR Training Provider will deliver the necessary training.

The Red Trained Operator cards cannot be renewed. This is to ensure the progression towards a Blue 'Plant Operator' card within 3 years.

#### • Blue Card - Plant Operator

All candidates are required to complete the CSR 1 Day Health & Safety Training and Operative Touch Screen Test. The candidate must achieve NVQ 2 in Plant Operations and must record a minimum of 300 hours operating experience on each category in the CSR logbook. Candidates who



cannot record 300 hours will be able to complete a site assessment in its place.

A Blue Plant Operator Card will not be issued unless six months has passed from the time of issue of the Red Trained Plant Operator Card, and the Operative Touch Screen Health and Safety Test has been passed within two years of the application date. The renewal requirement includes:

- CSR 1 Day Health and Safety Training
- Operative health and safety touch screen test

• Confirmation of 300 hours experience in each category of plant provided through CSR logbook or employer declaration. Where confirmation is not available a technical test delivered by a CSR Plant Scheme provider is required.

#### CSR cards accepted in the Republic of Ireland for Safe Pass ONLY

Schedule 4 of the Safety, Health and Welfare at Work (Construction) Regulations 2013 provides for the recognition of equivalent safety awareness schemes approved by SOLAS.

The Construction Skills Register (CSR Northern Ireland) one day health and safety course is the only course recognised by SOLAS as an equivalent to the SOLAS Safepass course. Any person wishing to avail of this recognition must be in possession of a current CSR Health and Safety card. This is confirmed on the SOLAS website <u>https://www.solas.ie/construction-lp/safe-pass/</u>

Candidates who have completed the CSR one day health and safety course will have a card with 'Accredited Safety Training' on the reverse, as illustrated. The only exception is the yellow Construction Site Visitor card - holders of this card have completed the one day course but it is not noted on the reverse of the card. It should still be accepted as equivalent to a Safepass card.
